


Disaster Recovery Payment and Allowance

2019-20 Victorian Bushfires



You should read this sheet with the Disaster Recovery Payment and Allowance guide.

Disaster Recovery Payment

Am I eligible?

For the 2019-20 Victorian Bushfires you may be eligible for Disaster Recovery Payment if you lived in one of the following Local Government Areas:

- Alpine
- East Gippsland

- Towong
- Wodonga

Centrelink may consider you 'adversely affected' if at least one of the following applies to you:

- You were seriously injured as a direct result of the bushfires
- An immediate family member was killed in the bushfires
- Your home was destroyed or suffered major damage in the bushfires
- A major asset was destroyed or suffered major damage in the bushfires
- Any of the above applies to a child in your care

Can I still claim Disaster Recovery Payment?

Claims for Disaster Recovery Payment for the 2019-20 Victorian Bushfires were due by August 2020. This means you are out of time to make a normal claim for Disaster Recovery Payment now.

You can still apply if you think that there are special circumstances that mean you should have more time to apply.

You can apply by calling the Centrelink Disaster Assist line on 180 22 66. You may wish to seek advice about your circumstances first.



Disaster Recovery Allowance

Am I eligible?

For the 2019-20 Victorian Bushfires you may be eligible for Disaster Recovery Allowance if you lived in one of the following Local Government Areas:

- Alpine
- Ararat
- Ballarat
- East Gippsland
- Falls Creek
- Glenelg
- Golden Plains
- Greater Bendigo

- Indigo
- Mansfield
- Mount Buller
- Mount Hotham
- Mount Stirling
- Moyne
- Northern Grampians
- Pyrenees

- Southern Grampians
- Strathbogie
- Towong
- Wangaratta
- Wellington
- Wodonga

No specific industries were identified by the Minister for the 2019-20 Victorian Bushfires. This means the kind of work you do does not affect your eligibility for Disaster Recovery Allowance for this disaster. If your loss of income is a direct result of the bushfires you may be eligible.

Can I still claim Disaster Recovery Payment?

Claims for Disaster Recovery Allowance for the 2019-20 Victorian Bushfires were due by August 2020. This means you are out of time to make a normal claim for Disaster Recovery Allowance now.

You can still apply if you think that there are special circumstances that mean you should have more time to apply.
